Dual Credit Overview

What is Dual Credit? A system under which an eligible high school student enrolls in college course(s) and receives credit for the course(s) from both the college and the high school.

What courses are eligible?

- 1) Those in the <u>core curriculum</u> of the public institution of higher education providing the credit;
- 2) a career and technical education course; or
- 3) a foreign language course.

^{*}No developmental education or remedial courses can be offered for dual credit.



Dual Credit Overview (cont.)

Exception -

An Early College Program Course...

 Any college course for dual credit offered as part of an early college program must be a core curriculum course of the public institution of higher education providing the credit, a career and technical education course, a foreign language course, or course that satisfies specific degree plan requirements leading to the completion of a Board approved certificate, AA, AS, AAS degree program, or FOS.



Dual Credit Eligibility

Student Eligibility –

Demonstration of college readiness via TSIA or through an exemption.

- ACT
- SAT
- Algebra II STARR EOC English III STAAR EOC

Other option – use a waiver to satisfy dual credit eligibility requirements (not college readiness)

- English II STAAR EOC Algebra I STAAR EOC (plus passing grade in Algebra II course)
- PŠAT/NMSQT

Not required for dual credit courses contained in a Workforce Education Level 1 Certificate.

Covid-19 TSI Exemption

COVID-19 College Readiness Exemption

Beginning the summer of 2020 and continuing through the 2021-2022 academic year, South Plains College will exempt dual credit students who cannot produce TSI, ACT, SAT or STAAR scores, from their college-readiness requirements for the next academic year, based on TAC 4.54(b).

High School students who want to use this exemption, must provide documentation (an unofficial transcript) to the Dual Credit Office that confirms a current high school GPA of 80 or above. For students who are incoming 9th graders, similar documentation must be provided to confirm that a student completed 8th grade with a final GPA of 80 or above.

Additionally, the following must be met to enroll in dual credit Math or English coursework -

For dual credit Math courses - a student must have an overall high school GPA of 80 or above, have successfully completed Algebra II at the high school level with a "C" or better, and have the approval of a high school counselor.

For dual credit English courses - a student must have an overall high school GPA of 80 or above, have successfully completed English II at the high school level with a "C" or better, and have the approval of a high school counselor.

Dual Credit – Instructional Requirements

<u>Curriculum</u>

• The college must ensure that a dual credit course and the corresponding course offered at the main campus of the college are equivalent with respect to curriculum, materials, instruction, and method/rigor of student evaluation.

<u>Faculty</u>

- Faculty must meet the same standards and approval procedures used by the college to select faculty responsible for teaching the same courses at the main campus of the college.
- The college shall supervise and evaluate instructors of dual credit courses using the same procedures used for faculty at the main campus of the college.

Dual Credit – Credentialing

Who is eligible to teach?

<u>Academic Transfer</u> – Master's degree with at least 18 graduate hours in the teaching discipline.

<u>Career and Technical Education</u> – Either a bachelor's degree in the teaching discipline or an associate's degree with <u>demonstrated competencies</u> in the discipline.



Adjunct Expectations

- Attend at least one department meeting per year;
- Submit course syllabi each semester;
- Verify class rosters each semester when notified by the Registrar;
- Submit final course grades by the deadline set by the Admissions and Records Office each semester;
- Submit an SPC grade book to the Admissions and Records Office at the end of each semester;
- Provide instruction consistent with departmental objectives and expectations;
- Adhere to SPC and departmental policies regarding grading, textbooks, evaluations, and curriculum;
- Check SPC email on a regular basis to stay apprised of information from SPC.



Course Syllabi

- Course syllabus must include all mandatory syllabus statements that apply to dual credit students:
 - Diversity Statement, Disabilities Statement, Non-Discrimination Statement, Title IX Statement, TexBook Statement
- Course syllabi must be submitted electronically to both the department secretary and to Kasey Reyes in Dual Credit Office.
- Submission deadline is Friday, August 27th
- Include course & section numbers, title, and correct dates.



SPC Curriculum Vitae (CV)

- New instructors need to submit a completed CV form to their department's secretary and Kasey Reyes.
- Returning instructors are encouraged to update their CV as changes occur.
- Vitae will be posted on the SPC website along with course syllabi.
- Vitae needs to be submitted by August 27th.




Class Rosters

- Verify your class rosters before the 12th class day.
- Students can't be enrolled after the 12th class day September 15th.
- Certification Instructions will be emailed to you from the Registrar.
- New Changes for Fall 2021: "Certify" button, select "Never Attended"
- Submission of official class rosters will be open from September 16th to 20th. Submission must be received by the deadline of September 20th at 10:00 am.

Final Grades

- Instructions from Registrar will be sent to your SPC email address.
- Grades must be submitted through Colleague Self-Service by the deadline.
- Each student must have both a letter and a numeric grade assigned to them. You will only enter a numeric grade on Self-Service – include both the letter & numerical grade in your final gradebook.



Grade Books

- Grade books must be submitted along with letter grade submissions to the Registrar's office. Email your final grade books to registrar@southplainscollege.edu.
- Make sure to include course prefix-number-section-term in the subject line (HIST-1301-001-2019FA).

Grade Change Forms must be completed within 6 months.



Departmental Procedures

During the upcoming breakout sessions -

- Department Chairs will discuss their expectations with department adjuncts.
- Department Chairs will discuss assessment process and requirements with your department.

- Remember your course must mirror the SPC course.
- Dual credit courses are expected to be conducted with the same rigor as classes on college campus.

Course Evaluations

- Dual Credit instructors are evaluated annually.
- Students must complete an online evaluation instrument towards the end of each semester – students will be notified when course evaluations are open.
- Evaluations are an accreditation requirement.



Disability Services

- Whether the student is taking the course in their own high school classroom, online, or at an SPC campus, the student must disclose their diagnosed disability(ies) to Disability Services in order to receive classroom accommodations.
- A school counselor or representative may assist in submitting/uploading all completed documentation and forms through the AIM portal.
- The dual credit student requesting accommodations is required to meet with Disability Services, in order to receive reasonable accommodations that are established for the student wanting to take college-level coursework.
- **Keep in mind** in college-level courses, <u>curriculum cannot be modified</u> for students with disabilities. Dual Credit students are expected to demonstrate the same level of understanding of all course material and meet the same minimum skill performance standards as every other student in the college class. High school IEPs nor 504 plans can be applied at the college level...



Career and Technical Education

Articulated Credit vs. Dual Credit

- Cost
- Immediately Transcripted

Summer Workshops and On-Campus Training

- During workshops, technical program coordinators and faculty provide teachers a list of sequential courses, which will count toward program certificate/degree.
- Technical program coordinators and faculty provide course content for every course that an instructor has been approved to teach, in order to guarantee course equivalency.
- Dual Credit instructors **must** teach college-level material and cover all required content, preparing students for more advanced courses, following high school graduation.

Degree Requirements (cont.)


Difference between the Associate of Arts & Associate of Science?

Associate of Science requires an additional Mathematics course (for 6 total hours) and eight hours of Lab Sciences (traditionally designed for STEM majors).

The Associate of Science degree only allows 11 hours of elective credit – normally reserved for advanced math or science coursework.

The 86th Legislative Session...

SB 25 – Transfer/Advising/Dual Credit

- Recommended Course Sequences
- Reporting of Nontransferable Credit
- Dual Credit Degree Plan (this requirement is also found in SB 1324).

SB 1276 – Partnership Agreements

This bill expands on the details required for an agreement between a public school district and their dual credit provider.

HB 3650 – Use of Open Education Resources (OERs)

This bill requires any agreement made between a school district and a public institution of higher education to provide for a dual credit program to consider the use of free or low-cost open educational resources in courses offered under the dual credit (September 1, 2019).



The 87th Legislative Session...

SB 1277 – related to agreements between a school district and public institution of higher education on providing a dual credit program to high school students enrolled in the district.

Registration Updates

August 30th - First day of class! (Blackboard will be made available to students on this date).

September 3rd – Last day to add an ITV or online class.

September 7th - Dual Credit payment deadline.

September 15th - Last day to enroll in a dual credit course that's being offered at a high school location. This date is also the 12th class day and serves as the College's official census date.

For students who register before August 30th - payment is due no later than close of business on August 30th.

For students who register after August 30th - payment will be due that same day of registration.

Last Year in Review

Over 2,600 students enrolled in dual credit coursework this Spring semester – more than 400 of those students were enrolled in CTE dual credit courses.
