I. COVID INFORMATION:

If you are experiencing any of the following symptoms please do not attend in-person classes and either seek medical attention or get tested for COVID-19.

II. COURSE INFORMATION

A. <u>COURSE DESCRIPTION</u>: A study of accounting for merchandising, notes payable, notes receivable, valuation of receivables and equipment, and valuation of inventories in a manual and computerized environment.

B. <u>LEARNING OUTCOMES:</u>

- 1. Define related accounting terminology
- 2. Analyze and record business transactions for a merchandising operation in a manual and computerized environment.
- 3. Calculate interest
- 4. Apply valuation methods for receivables and payables.
- 5. Utilize various inventory and depreciation valuation methods.
- **6.** Identify internal control procedures for inventory, receivables, and payables.
- C. <u>STUDENT LEARNING OUTCOMES ASSESSMENT</u>: This will vary and is geared towards Task Stream and WECM standards. This course will be assessed on an annual basis.

D. <u>ATTENDANCE POLICY:</u> As an online class, students must access the course on a regular basis. <u>Minimum log in for the course is at least four (4) days per week.</u> Additionally, you should not let more than 72 hours pass without logging in. Students will be administratively withdrawn from class if there is no log in activity for a twoweek period and/or no assignments completed during a two-week period.

The Blackboard software used to manage this online course tracks student logins, tracking when and where the student has been in the course. Accessing this course on a regular basis is extremely important in order to meet the objectives of this course. Ideally, students should daily check the semester schedule, e-mail, and also check for announcements and fellow student discussions. This course is not 100% self-paced—<u>there will be deadlines</u>. You will feel more at ease with the materials if you stay in touch with what is going on. This course is 3 semester credit hours. For this reason, you should set aside a minimum of 6 hours per week to work on this course. One of the very first things you should do is set aside time each week to work on the class. It is very easy to put off attendance in an online course.

A student who does not meet the attendance requirements of a class as stated, and does not officially withdraw from that course by the official census date of the semester, <u>may be</u> administratively withdrawn from that course and receive a grade of "X" as determined by the instructor.

An "F" will not be assigned to any student administratively withdrawn from a course for non-attendance by an instructor. **FINAL DROP DATE: Thursday – April 28, 2022**

- A. <u>BLACKBOARD</u> <u>ALL</u> communication and grades for this course will be conducted through Blackboard.

- B. <u>COURSE MATERIALS</u>: TexBook Program: This course is in the SPC TexBook program, so you do not need to purchase a textbook or access code for this course.
