# In-Class Attendance and Participation (10%)

Attendance is critical for this class in order to foster valuable class discussions and application of the material. We will also have several guest speakers throughout the semester and our presence is the biggest factor in getting and keeping speakers. For the grade portion it is simple: 50 Points if you are in class, 0 points if you are absent. 50 Points for participation (which includes answering questions and contributing to class discussions), 0 points if you remain silent. There will be NO makeups for missed classes. One or two missed classes will not negatively effect your grade, but repeated absences will do some damage.

<u>Videos and Video Worksheets (5%)</u> – Each chapter has multiple short video sections. Most will be covered during class time, but some will be required to watch on your own time. The VIDEO WORKSHEET has to be completed for a grade. It will not give you an option to submit, just fill in the blanks. It should save each answer as you type it. You may complete the worksheet while watching the videos (so bring your laptop/device to class for in-class videos).

<u>Chapter Activities</u> (20%) – These are assignments completed through the Foundations portal online. There is a designated folder titled Chapter Activities.

<u>Chapter Assignments (10%)</u> - Case Studies and Money in Review true/false questions are included in your Chapter Assignment grade.

<u>Chapter Quizzes (15%)</u> - Each chapter has a short quiz with multiple choice and true/false questions. Occasionally there may be a short answer question.

<u>Unit Exams (40%)</u> - There are 4 REQUIRED Unit Exams \*\*Note: There is NOT a comprehensive Final Exam\*\*

#### **EXTRA CREDIT**

There are two extra credit opportunities for a total of 3 points available for this class. Extra credit is offered to the entire class, NOT individual students. All extra credit points will be added to the *final* course average at the end of the semester.

- 1. Course Evaluation 1 point will be added to the final course average for completing the evaluation for this course. The course evaluation will be available at the end of the semester.
- 2. Course Assignments 2 points will be added to the final course average for students that complete EVERY assignment throughout the ENTIRE semester by the required deadline. There are NO exceptions for this opportunity.

A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of fever-reducing medication.
