I. COURSE INFORMATION

A. COURSE DESCRIPTION: A study of analyzing, classifying, and recording business transactions in a manual and computerized environment. Emphasis on understanding the complete accounting cycle and preparing financial statements, bank reconciliations, and payroll.

B. LEARNING OUTCOMES:

- 1. Define related accounting terminology
- 2. Analyze and record business transactions in a manual and computerized environment.
- 3. Complete the accounting cycle
- 4. Prepare financial statements
- 5. Apply accounting concepts related to cash and payroll.
- 6. Prepare bank reconciliations
- 7. Correct accounting errors
- 8. Complete a simulation for a personal service enterprise and a merchandising enterprise.
- **C.** <u>STUDENT LEARNING OUTCOMES ASSESSMENT:</u> This will vary and is geared towards Task Stream and WECM standards. This course will be assessed on an annual basis.
- D. <u>ATTENDANCE POLICY:</u> Students will be required to access the course on a regular basis, and attend class regularly if you are in a face to face or hybrid class. <u>Minimum log in for this course is three (3) days per week.</u> The Blackboard software used to manage this online course tracks student logins. The instructor is able to track when and where the student has been in the course and the amount of time spend working on an assignment.

Accessing this course on a regular basis is extremely important in order to complete the required assignments.

STUDENTS, and ONLY students, will be responsible for dropping the class if you are failing the class and do not want an "F" on your transcript. I will not drop anyone from the course because you stop coming or stop logging into Blackboard and complete assignments. A grade will be reported at the end of the semester based on the points that you earn.

When an unavoidable reason for class absence arises, such as illness, an official trip authorized by the college or an official activity, the instructor *may* permit the student to make up work missed. It is the student's responsibility to complete work missed within a reasonable period of time as determined by the instructor. Students are officially enrolled in all courses for which they pay tuition and fees at the time of registration. Should a student, for any reason, delay in reporting to a class after official enrollment, absences will be attributed to the student from the first-class meeting.

Students who enroll in a course but have "Never Attended" by the official census date, as reported by a faculty member, will be administratively dropped by the Office of Admissions and Records.

II. COURSE STRUCTURE:

- A. <u>BLACKBOARD</u> <u>ALL</u> communication and grades for this course will be conducted through Blackboard. You have many resources available to you for help and you can also contact me by e-mail, telephone, or come by my office.
- **B.** <u>COURSE MATERIALS:</u> This course requires the purchase of a Cengage Unlimited "card". The cost is approximately \$128 which includes tax.
