- Three-ringed Binder—This will be required to store all Homework (HW) that is assigned in the course; should be stocked with at least 250 sheets of loose-leaf writing paper and at least 100 sheets of graphing paper, which are sold separately
- Non-graphing calculators—These are allowed in this course and <u>cannot</u> <u>exceed</u> the <u>quality of a TI-36X Calculator</u>; no extra calculators are required of the Instructor to provide in the event of the Student not having his/her own
- Syllabus Acknowledgment of Receipt—The filling in, signing, and returning of said form is prerequisite for any accommodations stated in the syllabus to be recognized for the Student; nonetheless, the Student is still expected to uphold any responsibilities that are stated herein

The following materials and situational items are disallowed in this course:

  - o Usage during lecture may result in dismissal from lecture and a counted absence

- Online math answering programs—Programs that provide "solutions" to unworked problems, such as Chegg, MathWay, PhotoMath, and Wolfram Alpha are strictly prohibited from use in this course
  - o First Offense—Dismissal from lecture and counted absent
  - Second Offense—Student will be dropped from the course
- For aphing calculators—As most work will be required "by hand", the use thereof is prohibited; cell phone calculator usage is also disallowed; repeated violation will result in the dismissal of the Student from the course
- Pen for doing graded work—Use thereof in said circumstance will result in a zero percent (0%) for the assignment in question
  - o All work must be shown in pencil
  - o Writing each question in pen is permitted
  - o Circling/boxing answers in pen/highlighter is allowed
- Notes on exams—Use thereof in said circumstance that is not permitted by the Instructor will result in the immediate dismissal of the Student from the course.

## **HW Notebook Grading Rubric**

This is the rubric that will be used for the 2 homework (HW) notebook checks during the semester. Each HW notebook check will be worth a *minimum* of 4 points. There will be 5 criteria evaluated at each check, with each criterion receiving a <u>standard</u> maximum of 0.8 point:

- 1. All problems in each section are attempted, or no more than 1 problem is missing for every 10 problems assigned.
  - a. 1 point if *all* problems are attempted with work shown
  - b. 0.8 point if completely satisfied
  - c. 0 points if not satisfied
- 2. All work is shown for each problem, and the Student is using an AUTHORIZED calculator in this course.
  - a. 1 point if *all* answers are *correct* with related work shown
  - b. 0.8 point if completely satisfied with an authorized calculator
  - c. 0.4 point if partially satisfied with an authorized calculator
  - d. 0 points if not satisfied OR an unauthorized calculator is in use
- 3. HW is organized based on the lecture calendar, is kept in a 3-ringed binder as per the Syllabus, and is grouped based on the mid-term exams.
  - a. 1 point if tabbed with a copy of the Syllabus
  - b. 0.8 points if organized as stated
  - c. 0.4 point if not in a binder
  - d. 0 points if not satisfied
- 4. HW is made available upon request (on time) with all work done in pencil.
  - a. 1 point if completely satisfied with Acknowledgment of Receipt recorded
  - b. 0.8 point if completely satisfied
  - c. Prorated deduction for all sections not done in pencil
  - d. 0 points if late due to student negligence\*
- 5. Student correctly applies the information presented in the lecture to HW.
